● **Eligibility Criteria (To be read carefully before applying):**

1. Only those candidates who have qualified DAV CBT-2026 in the concerned subject and post shall be eligible to apply for Phase-3 (Demo & Interview)

● **Important Instructions / Terms & Conditions:**

1. Interested candidates possessing a valid PEC Card-2026 shall submit their applications only through the prescribed Proforma available at school reception. Applications submitted through any other mode shall not be considered

2. The date, time, and venue of the selection process shall be communicated only to those candidates who possess a valid PEC and fulfil the prescribed Eligibility criteria. Intimation shall be sent through E-mail and/or WhatsApp only. The Institution shall not be responsible for non-receipt of communication due to incorrect contact details provided by the candidate

3. Qualification in DAV CBT-2026 or possession of PEC shall not confer any right to appointment. Final selection shall be made strictly on the basis of performance in Demo and Interview and the decision of the Selection Committee shall be final and binding. No correspondence will be entertained in this regard.

4. Management may take up the verification of eligibility of a candidate at any point of time prior to or after the completion of Selection process, If it is found at any stage that the candidate is not eligible, then his /her candidature shall be summarily rejected.

5. No TA/DA will be admissible to the candidate for attending the recruitment process.
